REGULAR MEETING, January 10, 2017

*The Board held a work session at 5:30 p.m. to review building progress/budget.

*Roll call was taken. Board approved the agenda. Minutes from the December meeting were approved.

*Congratulations/Information—Wiggins Elementary earned the Governor's Distinguished Improvement Award for their performance on the CMAS assessments. Wiggins Secondary once again was recognized as Americas Best Schools with a bronze award. Elementary students of the month: Leah Rivas, Seyda Thomas, Skyer Armstrong, Alex Tarango, Mason Forsha, Makayla O'Patik. Alex Hishinuma was selected to receive a SAE Breeding Grant through the Colorado FFA Foundation. The Ag Science/Ag Business class submitted a FFA Grant application to get a drone, sensors and software. 40% of the seniors have been accepted to college and 97% are on track to graduate on time. 75 middle school students attended the Pride trip for good grades and behavior. 37 middle school students are interested in an 8th grade creative writing class.

*Mr. Kerr, Superintendent, reported secondary completed midyear NWEA testing before break. ACCESS testing (English Language Proficiency Assessment) is set for the end of January. The District Accountability committee has been meeting regularly to update the school district's vision/mission and goal statements. 4th grade teachers will have professional development on making furniture part of the learning environment. The Technology Director has updated the middle school computer lab and the hallway speakers in the elementary. E-Rate funding is expected to be cut in the years to come, the administration will begin looking at the technology budget.
